1) Pupil Premium at Sudell Primary School-Summary Information

The Pupil Premium was introduced in April 2011 and is additional funding schools have received based on the number of pupils who have ever been eligible for Free School Meals in the last 6 years. It also targets Looked after children (LAC), post-LAC children and service children.

At Sudell Primary School, Pupil Premium and Early Years Pupil Premium have been used in the following areas to support closing the attainment gap between children who receive Pupil Premium and those who do not.

Spending is targeted at increasing attainment to allow all children to reach their potential and at meeting their pastoral needs/developing the children's pastoral care. At we believe that children should not only achieve and attain well academically but also be ready emotionally to help them achieve their potential.

We are required by law to report to parents/carers about what we have spent the Pupil Premium on and the difference it has made.

<p>Work to continue through whole school approach to engage parents in their children's' learning by inviting them into school to talk with the teachers in informal and formal sessions to find out about what their child is learning.</p> <p>Parents will also be invited in to work in class along with their child on projects to allow them to see the methods used in school.</p> <p>Building this relationship will hopefully lead to increased parental involvement that will allow school to offer the support some parents need to improve home life for the children.</p> <p>School will also increase access support from Specialist Support Services to provide access to strategies to improve standards and learning outcome for children with the greatest needs.</p>

- Sudell is the **most improved** primary school at KS2 expected levels for Maths in Blackburn with Darwen
- Sudell has gone from 63rd (bottom school) for KS2 Maths outcomes in 2018 to 4th in Blackburn with Darwen in 2019
- Sudell is the **most improved** primary school for KS2 Reading at both the expected and higher levels in Blackburn with Darwen
- Sudell had the 2nd **biggest improvement** in KS2 higher standard in Writing (high), higher standard in Maths (high) and expected levels in GPS in Blackburn with Darwen
- Sudell had the **most improved** percentage of children achieving the higher standard for KS2 GPS in Blackburn with Darwen
- Sudell had the **biggest average increase** in KS2 scaled scores for each of the Reading, Maths and GPS tests for Blackburn with Darwen
- Sudell had the **biggest year on year improvement** at KS2 in the percentage of pupils reaching the expected standard in Reading, Writing, and Maths in all of the Blackburn with Darwen schools from 2018 to 2019
